


Project Status

- Site Preparation Package 1 is significantly complete and includes site grading, demolition, and placement of major water and sewer utilities.
- Interim Emergency Housing for Temporary Shelter Solution at the South End of the Project Site is underway as a Separate Project.
- Site Improvements Package 2 is the currently advertised project. This package involves the remainder of construction required to create a full-service and operable Temporary Emergency Housing shelter and site.
- Site Improvements Package 2 was advertised September 12th, September 16th, and September 23rd.


Project Location








Overview of Site Facilities

- SITE FACILITIES PRE-PURCHASED BY THE CITY OF TRACY
 - 60'x105' Sprung Structure (x1)
 - 40'x8' Shower Facility (x2)
 - 20'x8' Restroom Facilities (x2)
 - 20'x8' Laundry Facility (x1)
 - 20'x8' Mechanical Equipment Facility (x1)
 - Enclosure for Shower, Restroom, Laundry and Mech Facilities (x1)
 - 8'x20' Storage Containers (x3)
 - 8'x40' Storage Container (x1) (Class 2 AB Base Foundation)
 - ***Pre-Manufactured Kitchen Acquisition is Pending**

EACH PRE-PURCHASED FACILITY REQUIRES DISTINCT COORDINATION ELEMENTS



Concrete and Pavements



- Unique foundation systems for Sprung Structure and Restrooms/Showers/Mechanical/Laundry facilities
- Asphalt for parking and roadway
- Concrete for ADA Parking, sidewalks, curbing, gutters and various site work


Security Fencing



- 8' perimeter fencing & 7' interior fencing (approximately 3100 Linear Feet of fencing)
- Various gate systems including two powered vehicular rolling gates at entrance, one manual sliding vehicular gate, two pedestrian gates and other enclosure gates
- Electronic gate control system (Liftmaster)
- Site enclosure fencing at various locations (MEP at Sprung, storage areas)



Drainage and Landscaping



- Hydromodification and Bioretention areas
- Various landscaping and irrigation elements – ABI 4



Sprung Structure

- CONTRACTOR RESPONSIBILITIES

- Provide foundation for Sprung Structure that is cured and ready for placement of structure on foundation upon delivery
- Coordinate Delivery of Sprung Structure materials to Site
- Sprung be erected by Contractor with demonstrated experience in erection of high-tension membrane structures. Oversee erection of Sprung Structure
- Interior outfit of Sprung Structure
- Utility Connections
- *Note – NO exterior canopy to be provided

Restroom, Showers, Laundry and Mechanical Facilities



- CONTRACTOR RESPONSIBILITIES
 - Provide foundation system as described in project documents for Linked Equipment facilities
 - Coordinate Delivery of Pre-Fabricated container facilities and storage units to Site
 - Note: Individual containers or storage units may be delivered at separate times
 - Place Pre-Fabricated container facilities on foundation system
 - Construct equipment enclosure using elements delivered to site
 - Provide site utility connections
 - Provide nurse call system to be utilized for staff and operator Alerts from restroom interiors

Kitchen Facility – ABI 2

- CONTRACTOR RESPONSIBILITIES

- Provide foundation as described in project documents for Pre-Fabricated kitchen
- Coordinate Delivery of Pre-Fabricated kitchen facility to Site
- Monitor manufacturer's installation of kitchen on prepared foundation
- Provide connections to site plumbing and power utilities
- Provide and install grease trap for kitchen at site and connect utilities



Sewer Lift Station



- **CONTRACTOR RESPONSIBILITIES**
 - Furnish and Install Packaged Sewer Lift Station and Emergency Storage Basin
 - All Utility Work and Connections
