

TRACY CITY COUNCIL - SPECIAL MEETING MINUTES

December 20, 2024, 5:15 p.m.

Tracy City Hall, 333 Civic Center Plaza, Tracy, CA.

1. Mayor Arriola called the meeting to order at 5:21 p.m.
2. There were no actions taken pursuant to AB 2449.
3. Roll call found Council Members Evans, Nygard, Mayor Pro Tem Abercrombie, and Mayor Arriola present. City Council had no declarations of conflicts.
4. ITEMS FROM THE AUDIENCE – Alice English stated the last meeting was a fiasco which was expected and shared that there were more comments in favor of going with the Grand Jury. The voters voted Mateo Bedolla as third place. Council went against the voters. If you want to change the policy, bring it back for the 2026 election. The difference between Mateo Bedolla and Dotty Nygard was 250 votes, and shared concerns about Council changing the policy to be in their favor.

Mayor Arriola objected to the characterization by Ms. English.
