RECEIVE AN INFORMATIONAL ITEM TO UPDATE COMMISSION ON TARGETS IDENTIFIED IN THE SAP CHAPTERS 4 AND 5 RELATED TO WATER AND STORMWATER

EXECUTIVE SUMMARY

Chapters 4 and 5 of the SAP contain Targets and Measures related to the Environmental Topics of Water and Stormwater. This item will update the Commission on these targets and measures for both the Water and Stormwater areas of the SAP since the document was developed in 2008.

DISCUSSION

The City's SAP contains targets and measures related to the Environmental topics of Water and Stormwater in Chapters 4 and 5. The topic of Water is found under Chapter 4 Section E and Chapter 5 on pages 5-18 to 5-20. The topic of stormwater is found under Chapter 5 pages 5-22 to 5-23 Biological Resources BIO 5 – 7. Since the creation of the SAP in 2008, many of the targets have already been met or are being met through regulatory mandates. The City of Tracy is a growing community that has seen its population go from nearly 78,000 with a water demand of 17,891 AF (2005) to nearly 100,000 with a water demand of only 19,106 AF in twenty years.

The targets for water have primarily been addressed through the State and many of the related drought and conservation requirements. The identified targets in Chapter 4 and 5 are:

- Target #9a – reduction in Potable Water use from 2010 levels
- Target #9b – reduction in the per capita potable water use from Department of Water Resources Method 1 10 YR Historical Average (1995 – 2004)
- Target #9c – reduction in municipal water use from 2008 levels
- W-1 Potable Water Conservation through Development Standards, Public Education, and Municipal Wastewater Reuse
- W-2 Water Efficient Landscape Ordinance
- W-3 Incentives for Water Efficiency Retrofits
- W-4 Water Conservation Pricing

All of these targets (9a – 9c) have either been replaced with new criteria or are covered in an existing regulatory mandate. The City of Tracy, in compliance with the Urban Water Management Planning Act (<https://water.ca.gov/Programs/Water-Use-And-Efficiency/Urban-Water-Use-Efficiency/Urban-Water-Management-Plans>), prepares and adopts an Urban Water Management Plan update every 5 years (<https://www.cityoftracy.org/our-city/departments/utilities/water-resources/water-quality-supply>) since 2005. This plan along with the Water Management Plan required by the Bureau of Reclamation identifies the methods and practices that the City of Tracy enacts in order to ensure adequate water supplies are available to meet existing and future water needs. Many of these water conserving requirements have been met through plumbing standards which require manufacturers to reduce flow limits on many of their indoor fixtures such as toilets, faucets, washing machines, shower heads, etc. and outdoor uses such as handheld hose sprayers with on/off switches, irrigation standards for drip irrigation versus rotary, smaller nozzles on irrigation fixtures and low and drought tolerant vegetation requirements. It goes even further by mandating that beginning in 2023, the use of potable water for the irrigation of non-functional turf on Commercial, Industrial and Institutional (CII) properties are prohibited.

In 2015, it was estimated that about 40% of the water used in California was for outdoor irrigation. The Department of Water Resources developed and implemented the Water Efficient Landscape Ordinance (<https://water.ca.gov/Programs/Water-Use-And-Efficiency/Urban-Water-Use-Efficiency/Model-Water-Efficient-Landscape-Ordinance>) which required all new development and retrofitted landscape projects to comply with these standards. The City enacts this requirement and ensures compliance through the Planning and Building Department during plan review. It is also required to submit annual reports on implementation which may be found here <https://wuedata.water.ca.gov/>

Many requirements like 20 x 2020 and the most recent Urban Water Use Objective require drinking water suppliers to reduce their overall use by a certain percentage or to a certain level based on per capita demand. The City experiences about 12% water loss each year which is water that enters the system but is unaccounted for, meaning it wasn't billed through a meter. The City's goals currently are to reduce this loss and is also a requirement by the Department of Water Resources. This report is available here <https://wuedata.water.ca.gov/> under Annual Water Loss Reports.

The City provides up to \$20,000 annually in incentive programs such as their outdoor lawn and turf replacement program and outdoor irrigation controller rebate; and indoor programs such as their toilet rebate program for those homes and businesses that were built prior to 1992 and replace their 3 gallon or higher use toilet with a 1.8 gallon one. It will also provide a free in-home water use survey to find ways that a resident or business might be able to incorporate some water saving fixtures or devices to lower their monthly water bill and help reduce our potable water demand.

Finally, the City is currently beginning construction on their recycled water expansion project which in early 2026 will supply recycled water to Legacy Fields and for irrigation at the new Tracy Lakes Senior Development Community. For more information on the City of Tracy's current and future water management, the Water Master Plan was adopted by City Council in 2024 and may be found here <https://www.cityoftracy.org/our-city/departments/engineering/infrastructure-master-plans-fsited-1#/!> This document aids in the planning efforts of the City for future needs in infrastructure such as pipelines, pumps stations, Aquifer Storage and Recovery, and booster stations. The recycled water system will eventually

There are no Chapter 4 related stormwater topics, but the Chapter 5 identified objectives are:

- BIO-5 Stormwater Best Management Practices
- BIO-6 Joint Use of Retention and Detention Facilities
- BIO-7 Sustainable Storm Drainage Design

The City of Tracy is a Phase II Municipal Separate Storm Sewer System (MS4) designated entity and is permitted under the Phase II MS4 General Permit by the Regional Water Quality Control Board. The City under this permit developed a stormwater management plan in 2008 and must conduct an annual Performance Evaluation Assessment and Improvement Plan that is submitted to the State Water Resources Control Board. The Stormwater Management Plan identifies how the City will ensure the protection of receiving water bodies from stormwater discharged through its

storm drainage system. This is conducted through minimum control measures under various topics. Topic BIO-5 is required on all private and public construction projects under either the City of Tracy Erosion and Sediment Control Plan or a Stormwater Pollution Prevention Plan. These plans identify the best management practices (bmpps) that a project will incorporate to reduce or eliminate the transport of sediment, trash, and debris from their construction site.

The City also requires all development projects to comply with its Post-Construction Stormwater Standards which is implemented and enforced through Conditions of Approval and Plan Review process. This document may be found here <https://www.cityoftracy.org/our-city/departments/engineering/land-development>. BIO-6 Joint Use of Retention and Detention Facilities would be incorporated through these standards for both public and private projects. An example of this type of requirement was shared with the Commission in the presentation of the Multi-Recreational Generational Center, in which the central grass area serves as both a stormwater detention area and a play area. Plascencia Fields on the southwest corner of 11th and Corral Hollow Rd is also a dual use facility in that it serves as stormwater detention in large flooding events as well as a soccer field.

BIO-7 Sustainable Storm Drainage Design will be discussed in more detail in the presentation by Engineering and Community and Economic Development at a later date.

EXECUTIVE SUMMARY

There were 11 topics covered in the SAP and Commissioners in attendance were given the opportunity to select two of the topics at that meeting and/or wait till further discussion at the March 27, 2025, meeting. Two of the Commissioners selected their topics at this meeting. This item is to discuss and appoint the remaining topics to each of the Commissioners to be the subject matter expert during presentations on those topics at future meetings.
