PUBLIC HEARING NOTICE

The City of Tracy City Council will conduct a Public Hearing on Tuesday, June 17, 2025, at 7:00 p.m., or as soon thereafter as possible, in the Tracy Council Chambers, 333 Civic Center Plaza, to consider:

**Annual Tracy Consolidated Landscape Maintenance District Assessment for Fiscal Year 2025/2026 pursuant to the California Landscape and Lighting Act of 1972 and California Streets & Highway Code § 22623 et seq.:**

1. **The City Council will be considering adopting a Resolution approving the Engineer's Report regarding the proposed levy and collection of assessments for the Tracy Consolidated Landscape Maintenance District for Fiscal Year 2025/2026; and**
2. **The City Council will be considering adopting a Resolution ordering the levy and collection of assessments within the Tracy Consolidated Landscape Maintenance District for Fiscal Year 2025/2026.**

The City maintains the Tracy Consolidated Landscape Maintenance District to provide funding for electricity and maintenance costs associated with the City's network of streetlights, and for certain landscape and public facilities maintenance as funding allows. Details of services, costs, special vs. general benefits, justification and individual property assessments are contained in the Engineer's Report. The Engineer's Report is on file in the City Clerk's office. They are available for inspection by contacting the City Clerk's office. The public is invited to appear and present their views.
