

TRACY CITY COUNCIL - SPECIAL MEETING MINUTES

June 3, 2025, 5:00 p.m.

Tracy City Hall, 333 Civic Center Plaza, Tracy, CA 95376

1. Mayor Arriola called the meeting to order at 5:00 p.m.
2. There were no actions taken pursuant to AB 2449.
3. Roll Call and Declaration of Conflicts – Council Members Evans and Nygard; Mayor Pro Tem Abercrombie, and Mayor Arriola were present. Council Member Bedolla was absent from roll call. City Council had no declarations of conflict.

Council Member Bedolla arrived at 5:14 p.m.

4. Items from the Audience – There were no items from the audience.
5. DISCUSSION ITEMS

- 5.A. Staff recommends that the City Council conducts a workshop, receives information, and provides feedback regarding 1) the proposed Fiscal Year (FY) 2026 Capital Budget, and 2) the proposed five-year FY 2026-2030 Capital Improvement Plan.

Roll Call found Council Members Bedolla, Evans, and Nygard; Mayor Pro Tem Abercrombie, and Mayor Arriola all in favor; passed and so ordered.

Public Comment – Ross Bogen shared concerns regarding the historical buildings, specifically the old City Hall and jail, and asked if there is a plan for seismic improvements, since these buildings are Designated Historical Landmarks.

Cynthia Souza, President of the Grant Foundation Board, requested that the City Council prioritize the restoration of the old City Hall and jail since it is listed on the National Register of Historic Places and expressed that she would like the project to be added to the Capital Improvements budget for Fiscal Year 2025-2026.

Mary Mitracos indicated that the community is ready for the Nature Park and the Tracy Tree Foundation and Nature Park Advocates are ready to assist in the tree planting process; and noted the importance of the restoration of the historical buildings downtown.

Robert Tanner expressed support for a Police Department substation and more officers and inquired as to when that subject will be brought back to the City Council.

A Community Member expressed the importance of restoring the downtown historical buildings, as they are a tie to the past.

Bill thanked the City for trimming the trees in his neighborhood.

Mayor Arriola closed Public Comment.
