

**CITY OF TRACY CITY COUNCIL
PUBLIC HEARING**

The City of Tracy City Council will conduct a Public Hearing on **Tuesday, August 19, 2025, at 7:00 p.m.**, or as soon after as possible, in the Tracy City Council Chambers, 333 Civic Center Plaza, Tracy, to consider and take action on:

Applications ZA25-0001, R24-0001, P25-0003, TSM24-0001, and D24-0003: The Triway Project – Public hearing to consider (1) an ordinance adding Article 9.5, Small Lot Residential Zone, to Chapter 10.08 of Title 10 of the Tracy Municipal Code, Sections 10.08.1471 through 10.08.1479, and determining that this zoning text amendment is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3), (2) an ordinance approving a rezone from Light Industrial to Small Lot Residential for the Triway project site, consisting of four parcels totaling approximately 22.6 acres located in the vicinity of 200 Valpico Road, Assessor's Parcel Numbers 246-130-03, 246-130-04, 246-130-05 and 246-130-06, (3) a Vesting Tentative Subdivision Map to create 275 single-family residential lots and various common area parcels, (4) a Development Review Permit for the residential architecture and development plan, and (5) a determination that the project is consistent with the General Plan Environmental Impact Report (EIR) and therefore, is exempt from the California Environmental Quality Act (CEQA), pursuant to CEQA Guidelines Section 15183. *The Project Planner is Craig Hoffman, Senior Planner, (209) 831-6426, Craig.Hoffman@cityoftracy.org.*

The Applicant is Brookfield Bay Area Holdings, LLC and the Property Owners are Geurtje and Stanley Boersma, Annette Elissagaray, David Boersma, Julie and Wahid Tadros, Hacienda Ranch Homes, and Peter and Karen Bareiss.
