RECOMMENDATION: COUNCIL REQUESTED WORKSHOP

Receive an informational presentation on the “Community Plans” for the development of an Aquatic Center in the City of Tracy.

EXECUTIVE SUMMARY

At the June 3, 2025 City Council Meeting, Mayor Pro Tem Abercrombie requested a presentation on the Aquatic Center “Community Plans”, which have been discussed by a group of community members at several City Council meetings as well as in the media. The “community plans” include designs, construction elements, and other information pertinent to the “Community Plans” for the development of an Aquatic Center within the City of Tracy. This request was seconded by Mayor Arriola. A Council Workshop was elected as the appropriate method to have the item presented as the information and material needed for such a presentation is voluminous.

BACKGROUND AND LEGISLATIVE HISTORY

For several years the City of Tracy has considered and planned for the development of an Aquatic Center which was envisioned to include a 50-meter pool, lazy river, warm-up pool, water slide, along with additional components. In 2017 the City Council took several actions which included direction and guidance on the development of plans for the Aquatic Center. As the intent of the City Council has been to locate the Aquatic Center within the Ellis residential development, the initial designs and conceptual elements brought to council were formed by the Developer, Surland, LLC (“Developer”), of the Ellis Specific Plan Area. At the time, the Developer worked collaboratively with City staff as well as a community group, the latter of which came to be colloquially referred to as the “Aquatic Center Task Force”. Concurrent to this time, a lawsuit (*Mitracos v. City of Tracy et al*) was filed by a community member against the Developer and the City. While the lawsuit worked its way through the courts, work continued with the Developer taking the lead in the design work with regular City staff involvement.

On August 18, 2020, Council approved the Aquatic Center Final Conceptual Plan as prepared by the Developer. Council directed staff to work with the Developer on project phasing and implementation plans. Work continued in this manner until on or about October 8, 2020, when the City received final judgement of the *Mitracos v. City of Tracy et al*, at which point the collaborative design work between the City and the developer on the development of the Aquatic Center was ceased. Between October 2020 and Fall of 2024, the Aquatics Center project design paused as the Developer and City attempted to work through any legal matters that may relate to the development, funding, and construction of the project. In 2022, the City took several actions, which returned the responsibility for designing and constructing the facility back to the City. On September 17, 2024, Council awarded a Professional Services Agreement with Group 4 Architecture, Research + Planning, Inc. and directed staff to return in the spring after completion of conceptual designs with price points ranging from \$55 million to \$65 million with other optional project amenities based on community priorities.

In late 2024 through the spring of 2025 the City commenced a community process of developing an Aquatic Center design with the intent of it being constructed as a City CIP. Development of the conceptual design included a review of previous community input as well as reaching out to the Aquatic Center Task Force. The meetings resulted in the Aquatic Center Task Force requesting that the Council receive a presentation on the original designs and be allowed to make an informed decision based on a full understanding of the prior designs prepared at the direction of the City. Concurrently the City and Developer commenced discussions regarding their outstanding matters and as discussions progressed in a positive manner for both the City and the Developer, the Developer expressed a desire, support and willingness to present to Council the original Aquatic Center designs, the completed design development plans, and the financial performance and user experience the City can expect to realize if the City decides to use the original Aquatic Center designs.

On June 3, 2025, the Mayor Pro Tem Abercrombie requested that staff return with a presentation and discussion on the “Community Plans” for an Aquatic Center. This was seconded by Councilmember Mayor Arriola.

ANALYSIS AND DISCUSSION

It has been several years since staff has worked alongside the developer on the development of the original Aquatic Center designs, now colloquially referred to as the “Community Plans”. Staff believes and understands that the status of the “Community Plans” have progressed beyond conceptual designs and may include financial analysis of the viability of the project. As staff is not the most informed or knowledgeable people on the latest status of the “Community Plans” it would be more appropriate and accurate to have the “Community Plans” presented to Council by the Developer, their consultant team and the community group that was intimately involved in the development of these designs.

The presentation of the designs to the Council will be made by Surland Communities (Developer)’s Aquatic Center Design consultants: Urban Design Associates, Water Technology Inc., Pro Fun; and Community members from the Aquatic Center task force.

FISCAL IMPACT

This Council workshop is informational in nature only and will have no fiscal impact on the City. Should the Council choose to take further action on the designs this may lead to additional expenditures by the City related to the development of the “Community Plans”.
