**EXECUTIVE SUMMARY**

During the February 27, 2025, meeting, Item 7.C - Action Item #3 of that meeting requested that Commissioners return with a discussion to appoint volunteers to a specific topic within the SAP to make policy recommendations. There were 11 topics covered in the SAP and Commissioners in attendance were given the opportunity to select two of the topics at that meeting and/or wait till further discussion at the March 27, 2025, meeting. Two of the Commissioners selected their topics at this meeting. This item is to discuss and appoint the remaining topics to each of the Commissioners to be the subject matter expert during presentations on those topics at future meetings.

**DISCUSSION**

The SAP contains 11 environmental topics that are covered in the document. Those environmental areas are:

- Greenhouse Gas Emissions
- Energy
- Transportation and Land Use
- Solid Waste
- Water
- Agriculture and Open Space
- Biological Resources
- Air Quality
- Public Health
- Economic Development; and
- Outreach and Education

Of the four Commissioners in attendance, each were given the opportunity to make a selection on two of the topics to be the subject matter expert when presentations were being brought forward to the Commission at later dates. These presentations would be updates to the topic sections in Chapter 4 and 5 of the SAP. Commissioner Shoaito selected Water and Biological Resources and Commissioner Kahlon selected Air Quality and Agriculture and Open Space. The other two Commissioners did not choose at this time.

**EXECUTIVE SUMMARY**

The By-Laws for the City of Tracy Environmental Sustainability Commission (ESC) requires that an annual report be presented to the Tracy City Council identifying the work completed in the prior year and work plan for the next year. This item requests that Commissioners discuss, make recommendations, and approve as final the draft presentation for City Council.

**DISCUSSION**

At the January 23, 2025, meeting, Stephanie Reyna-Hiestand, reminded the Commission of its obligation to prepare an annual report to be presented by Chair Wood or another member at a Council Meeting. Chair Wood volunteered to prepare a draft presentation based on other City Commissions presentations and bring it back for discussion and recommendation by the ESC for the final presentation to Council.

The proposed items for inclusion were:

- Formed the Sustainability Action Plan Ad Hoc Committee to bring information back to the ESC on sections of the SAP to update or request Council policy
- Received information reports from various city departments and local businesses on sustainable practices and implementation of mandates such as the Solid Waste subdivision of Public Works – food waste and compliance with SB1383, Heirloom – Carbon sequestration and San Joaquin Valley Air Pollution Control District – Tracy Air Quality
- Recommended that City Council adopt the Urban Forest Master Plan after discussion and review
- Reviewed and submitted Commission comments on the Recirculated Draft Environment Impact Report Chapters for the Tracy Costco Depot Annex Project
- Reviewed the Draft Environmental Impact Report for the Schulte Road Warehouse Project
