Before the day is over, I wanted to express my deepest concern over the accident involving 2 young children that occurred on Halloween night at the corner of Gandy Dancer/Rockport and Tracy Blvd. We trick or treated in that same neighborhood just minutes before the accident occurred. I can't imagine the horror their parents felt. My heart goes out to them. When I read the location of where the accident occurred, I was not surprised at all. I drive down Gandy Dancer weekly to take my 2 young children to the rec center. And I have to jump across 4 lanes of traffic with zero traffic signals and the Tracy blvd traffic is zooming down that long stretch of road at 60+ mph. It's almost impossible to turn left there. It's nearly deadly to turn left there. I will drive all the way down to McDonalds (Valpico) just to make a U-turn to drive the opposite way. Especially with my babies in the car.

Please install traffic lights at that intersection. Before somebody else gets hurt.
