## **CITY OF TRACY NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN** that that the City Council of the City of Tracy will conduct a Public Hearing per the Elections Code during its regular City Council meeting on **Tuesday, November 18, 2025, at 7:00 p.m.** at Tracy City Hall, Council Chambers, 333 Civic Center Plaza, Tracy, California, 95376. The Public Hearing will be the first item of regular business conducted at the meeting. During this Public Hearing, the City Council will: 1) receive a report from staff and the City's demographic consultant on the districting process, permissible criteria to be considered to draw City Council Member election district boundaries, and public outreach; 2) provide and receive input from the public on the composition of voting districts before maps are drafted; and 3) provide initial direction to the demographic consultant on composition of draft maps. The Public Hearing will be held in person at the address listed above with an option for public participation via teleconference (Webex) as outlined below. Refer to the meeting agenda for additional information.

All interested persons are invited to attend said Public Hearing and express opinions relating to this matter.
