POWERS AND DUTIES:

As set forth in the Bylaws adopted by Resolution 2009-198, as amended by Resolution 2010-022 of the Tracy City Council

MEETINGS:

The Tracy Arts Commission shall meet the second Tuesday of each month at 7:00 p.m.

The Tracy Arts Commission shall have the responsibilities and duties to:

- Establish such bylaws, rules and procedures as may be required to conduct Commission activities.
- Encourage, promote and stimulate the growth of broad-based arts and cultural programs in the community.
- Strive to maintain an active and broad-based representation of community arts interests on the Commission.
- Pursue and solicit private, regional, State and Federal funding support for arts programs and facilities development.
- Perform other arts-related duties and functions as the City Council may direct.

QUALIFICATIONS: The Tracy Arts Commission of the City of Tracy shall consist of seven members who reside within the city limits of Tracy. Members may not be officials or employees of the City.

Should a commission member fail to attend four (4) meetings and is unexcused for those absences, his/her position on the Commission shall become vacant.

Members heretofore appointed shall complete the terms for which they were appointed, and their successors shall be appointed for terms of four years, except in the case of unexpired portions of terms. If a vacancy occurs other than by the expiration of a term, the vacancy shall be filled by an appointment to the unexpired portion of such term.
