The City of Tracy Community and Economic Development Director will conduct a Public Hearing on **Wednesday, December 3, 2025, at 1:00 p.m.**, or as soon after as possible, in Conference Room 203, located on the 2<sup>nd</sup> floor of City Hall, 333 Civic Center Plaza, Tracy, to consider and take action on:

**Application EPBC25-0003: Ellis Village Center Design Review** – Public hearing to consider (1) approving the Ellis Pattern Book Certification, Application Number EPBC25-0003, for the construction of one commercial building, totaling approximately 4,517 square feet, and related site improvements on a portion of a 6.45-acre site, known as the Ellis Village Center, located at the southwest corner of Ellis Town Drive and S. Corral Hollow Road, Assessor's Parcel Number 240-140-68; and (2) determining that this project is consistent with Ellis Specific Plan (ESP) Environmental Impact Report (EIR), certified by City Council on January 22, 2013, for the Modified Ellis Project, which included the Modified Ellis Specific Plan (SCH#2012022023). Pursuant to CEQA Guidelines Section 15162 and Public Resources Code Section 21166, no additional environmental documentation is required.

**The Applicant is Regency Centers, and the Property Owner is Surland.**
