As a 17 year resident of Redbridge, I do not feel it beneficial to the community or to the city, that we request Tracy PD spend their hard earned time monitoring a gated community for minor traffic infractions which are virtually nonexistent. With the growth of the city over the past decade the Police Department's presence and service are far more needed and beneficial throughout the many other areas and neighborhoods of Tracy.

Myself and many other residents have come to feel like Redbridge is a small refuge and sanctuary from a more hectic daily lifestyle outside of our community. I personally, along with other residents I've spoken with, have never experienced any traffic violations or infractions within our community, beyond what could not be resolved by, speaking to and expressing the importance of safe driving and abiding by all laws, to younger residents/new drivers, as well as visitors. Many of our fellow neighbors here find it a bit selfish and unwarranted, that an angry few disgruntled residents, who feel that they've had a bad experience while out walking their dogs, would deem it appropriate to monopolize Tracy PD's valuable time monitoring for minor traffic infractions in a gated community, while there are more pressing issues around the city to which they could devote their service to.

This resolution proposal seems to be based solely upon vindictiveness rather than actual necessity. Furthermore, it would take away from the pride, sense of community and sanctity the residents of our small neighborhood enjoy, as well as ( and most importantly ) take hard working Tracy PD Officers away from other areas of the city and community where their service is much more needed and pertinent.
