Commissioner Dhugga suggested that it would be great to have a studio for artists to show how they create their pieces. Chair Lees agreed, adding artists need space to rent. Commissioner Jones suggested the West Side Market building would be a good location to expand arts programming. Chair Lees agreed and further suggested studio and musical instrument rentals, comparing Tracy to Midtown Sacramento. Commissioner Dhugga stated that concerts are good, but it's better to have a place where people can be introduced to arts.

REVIEW AND APPROVE 2025 RE-GRANTING PROGRAM APPLICATIONS

DISCUSSION

The 2025 Re-Granting Program will award up to \$4,000 (two \$2,000 grants) to Tracy resident artists, arts educators, and arts organizations (both collectives and non-profits). Tracy residency is defined as having a primary residence in the City, and/or teaching at a public or public charter school in Tracy, within the City limits.

Staff released the Call For Applications to the community-at-large in September and has worked to distribute information in both digital and print formats to the creative community. An informational workshop was held on Thursday, October 9 with one participant. Applications had to be received by 5:00 PM PST at the Grand Theatre Center for the Arts on Friday, November 21 in order to be eligible for review by the Tracy Arts Commission.

Staff will present the eligible applications. The Commission will review and evaluate the applications with the following criteria, with each review providing a total possible high score of 75 (15 points x 5 reviewers) per application:

Artistic and/or Educational Excellence – 5 points:

Measure of the creativity (new, original and/or interesting ideas), quality (technical skills) and strength of content (concept and educational value) of the project.

Community Impact – 5 points:

Measure of the diversity and representation of the intended audience(s), activity/event location(s), viewer/participant engagement, and the applicant's collaborations within the project (if applicable).

Ability to Fulfill Project – 5 points:

Measure of the ability to develop and complete the project as described, the experience of the applicant and collaborators, and the project budget.

Each reviewer may score an application between 3/15 (lowest) and 15/15 (highest). After review, total scores will be determined and the TAC will award funds to those with the highest overall scores. In the event of tie scores, the TAC will continue discussion as needed to determine awards.

FISCAL IMPACT

Appropriation of Tracy Arts Commission funding in the Cultural Arts Division budget in the amount of \$4,000 has been approved for 2025 Re-Granting Program.

**REVIEW REQUEST FOR QUALIFICATIONS FOR THE TRACY TRANSIT
STATION MOBILITY HUB PUBLIC ART PROJECTS AND RECOMMEND
FINALIST(S)**

DISCUSSION

City Staff in collaboration with San Joaquin Council of Governments (SJCOG) and design consultants are working to implement the San Joaquin Regional Mobility Hub Plan. The Tracy Transit Station (TTS) at 50 E 6th St. in downtown Tracy has been selected as a demonstration project, serving as a model to guide future mobility hub development and community enhancement efforts throughout the region.

As part of the site improvements at the Tracy Transit Station, funded through the Regional Early Action Planning Grants of 2021 (REAP 2.0, administered by California's Department of Housing and Community Development) public art is eligible when integrated into transportation infrastructure. Public art at the TSS will serve as creative placemaking features, enhance the transit environment and support the program's goals. Selected artists will need to engage the community in the creative process. The budget for the TTS mobility hub public art projects is \$150,000.

The Tracy Arts Commission discussed the integration of additional public art into the surrounding plaza of the TSS, and provide recommendations which address project goals and outcomes in September. Staff issued a Request for Qualifications (RFQ) in November. The RFQ is designed to identify qualified artists, who would then be invited to develop proposals and be commissioned to create projects.

Staff will present the eligible applications. The Commission will review and evaluate the applications with the following criteria, with each review providing a total possible high score of 75 (15 points x 5 reviewers) per application:

Professional Qualifications – 5 points:

Measure of abilities, credentials and skills as a professional artist needed to develop and complete the project.

Community Collaboration and Local Connectivity – 5 points:

Measure of interest in and experience with creative projects that include components of community collaboration. Familiarity with the City of Tracy and San Joaquin County.

Creativity and Quality of Work – 5 points:

Measure of new, original and/or interesting ideas in art making, communication and viewer engagement, etc. Mastery of technical skills, effective use of materials utilized in work, innovative techniques, etc.

Each reviewer may score an application between 3/15 (lowest) and 15/15 (highest). After review, total scores will be determined and the TAC will recommend finalists in consideration of the highest overall scores. In the event of tie scores, the TAC will continue discussion as needed to determine recommendations.

FISCAL IMPACT

There is no fiscal impact to the Cultural Arts Division in support of this project.

DISCUSSION

The Tracy Arts Commission's (TAC) programming funding resides in the administrative accounts of the Cultural Arts Division (CAD) budget. The TAC meets annually to discuss funding and programming, forming recommendations in effort to best meet goals. CAD Staff reviews and approves the expenditures.

The TAC FY25-26 allocation is \$15,000. The TAC has already committed to provide \$3,150 to continue the co-presentation of Open Mic Nights as part of the Grand Theatre Center for the Arts' 2025-26 Presenting Season. The TAC began discussion of this item at the meeting of September 9, 2025. Discussion will continue on this item at the December 9, 2025 meeting. Staff expects to have finalized budget and recommendations at the February 10, 2026 meeting.

CONTINUE DISCUSSION OF CITY OF TRACY ARTS PLANNING

DISCUSSION

The Tracy Arts Commission (TAC) was formed by the City Council for the purpose of preserving and cultivating the expression and appreciation of the Arts in Tracy. The Tracy Arts Commission (previously known as the Cultural Arts Commission and Community Cultural Arts Commission) was established in 1991 for the purposes of: maintaining the Civic Art Plan (adopted by City Council, Reso 2003-002), contributing to the quality of life of the residents of Tracy through the high quality civic spaces and access to a broad array of artistic experiences, expanding the knowledge and understanding of the community's history and culture, supporting the economic vitality of the City through increased property values and cultural tourism, and reinforcing downtown as a cultural destination.

The Tracy Arts Commission (TAC) advises the City Council on the subjects of Citywide public art including private development and public/private partnerships, fosters public/private partnerships for the creation of civic art, supports individuals and organizations involved in the arts by promoting their events, offering resources, educational tools, and advising on policies to City Council that will support those endeavors, and commits to nourishing artistic vision, honoring diversity, supporting creativity and promoting cooperative partnerships through the Re-Granting Program.

The City Manager's Office has requested the TAC begin a discussion in consideration of the City of Tracy's arts planning. The TAC should consider a wide range of arts assessments, ideas, topics and goals such as, but not limited to, arts and cultural events, amenities and facilities, arts funding, creative community collaboration, the concept of a Cultural Arts Department and the vision of a Downtown Arts District.

Staff anticipates continued discussion will continue as needed for several months, with a goal to create recommendations in 2026 that can be utilized in City planning. Discussion began at the meeting of October 14 and continued at the November 12 Special Meeting with the following suggestions and talking points provided for on-going consideration:

Arts & Cultural Venues:

- Outdoor performing arts venue / stage
- New Library that is two to three times larger than the current facility
- Makers Space

- New Community Center that integrates into the Civic Center Plaza
- Tracy Historical Museum exterior maintenance and new landscaping
- Gallery that is “Studio Style” with adaptable workspace

Arts Funding:

- More arts funding, including support from the private sector and City tax support

Arts Programming:

- Present performers who are creating original works; less tribute bands
- Artist Exchange with Sister Cities
- Launch the Poet Laureate program
- Artist Residency Program
- Interactive Programming
- Library Loan Program that lets users to borrow Musical Instruments, Tools, etc.

Arts Redevelopment, Marketing & Branding:

- Professional Development for Artists
- Grant Writing Workshops
- Use of West Side Market
- Make us of unused Property/Space
- Create a Cultural Arts Department
- Establish a Downtown Arts District
- New banners with updated City and arts branding, that are not cheesy or use bad slogans

Public Art:

- Additional opportunities for City-wide public art; murals and utility boxes

FISCAL IMPACT

Staff costs related to support of the Tracy Arts Commission are included in the Cultural Arts Division Administrative General Fund budget.
