The City of Tracy City Council will conduct a Public Hearing on **Tuesday, January 20, 2026, at 7:00 p.m.** or as soon after as possible, in the Tracy City Council Chambers, 333 Civic Center Plaza, Tracy, to consider the following:

Project Number AP25-0001: GURU BAAZ Annexation & Pre-zoning – Public hearing to consider: (1) Authorizing the City Manager to submit a petition to the San Joaquin County Local Agency Formation Commission (LAFCo) to annex approximately 3.9 acres consisting of two parcels located at 21323 S. Tracy Blvd., Assessor's Parcel Number 212-170-26, and 21235 S. Tracy Blvd., Assessor's Parcel Number 212-170-19 (the “Property”) and (2) adopting an Ordinance approving the pre-zoning of the Property to Community Recreation Support Services (CRS) Zone (exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15183 (Consistency with General Plan)).
