Mayor Rickman called the meeting to order at 7:02 p.m.

Jacy Krogh expressed concerns regarding leave of absence requests by appointed commissioners and requested Council re-evaluate the use of the leave of absence policy for those that serve on the appointed commissions and boards.

City Council comments followed.

2. ITEMS FROM THE AUDIENCE – Sheri Savage shared her frustration regarding the euthanizing of animals at the Tracy Shelter. Ms. Savage requested a subcommittee of members of the community to decide when an animal should die.

Caroline Grayson shared her concerns about the kennel I.D. number/information not being on the cages at the Tracy Animal Shelter. Ms. Grayson submitted photos to the Clerk.

Dave Helm announced that the FPPC will be investigating his complaint against Mayor Pro Tem Young related to a fireworks stand permit issued to nonprofit organizations through the lottery process. Mr. Helm provided a handout.

Council Member Young responded to Mr. Helm's allegations stating the City Attorney had contacted the FPPC to get a writing as to whether she did anything improper. Council Member Young clarified she ran on "Voice Matters' which is why she fought for the organizations, and looks forward to the FPPC's response.

Thomas Watson, City Attorney provided the staff report.

City Council questions and Comments followed.

Dave Helm shared his concerns regarding limiting the public comments and use of speaker cards.

Robert Tanner suggested that Council members who have received campaign donations of \$4,000 or more from developers should not be able to vote on that builder's request before Council, for the first 2 years in office. Mr. Tanner expressed concerns about limiting public comment, and speaker card issues.

Steve Nicolaou stated requiring a speaker card is unconstitutional, and the public comment period should be at the beginning of the meeting. Mr. Nicolaou referred to Article V of the San Joaquin County Board of Supervisors Code of Ethics regarding Code of Ethics violations, and suggested similar language should be added to the City's Code of Ethics.

Martin Evans stated he does not like meetings televised or late at night and suggested have one meeting a month on a Saturday.

Jacy Krogh encouraged Council to think twice about moving the public comment period to the end of the meeting.

Alice English stated speaker cards are a violation of rights, and did not support putting the public comment period at the end of the meeting. Ms. English added residents should know they have a right to go to the FPPC to hold Council accountable. Ms. English suggested a timer for Council Members, and not to censor the public.

Roger Birdsall did not support moving the public comment period to the end of the meeting. Mr. Birdsall referred to the County Code of Ethics Mr. Nicolaou had provided previously and suggested using them as a guide.

City Council made comments regarding various sections of the proposed Code of Ethics.

City Council moved the item to the end of the meeting following item 6.E.

Conrad Levoitt stated it is a serious issue when a person is smoking cannabis in a neighborhood and should take certain precautions of where they choose to smoke it, not in car, street or side of residence.
