REVIEW AND APPROVE DEACCESSION OF FABRIC PANEL #5 ARTWORK FROM THE CITY ART COLLECTION

DISCUSSION

Periodically, as part of the lifespan of art and objects held within the City Art Collection, Staff seeks the recommendation of the Tracy Arts Commission to access or deaccess significant works. As part of the Civic Art Program Staff Report in January, Staff advised that *Fabric Panel #5* by Mark Thomas (CAC # 2007-006-005) was damaged, would be de-installed, and examined. In March the work was removed from display and inspected. It was found that this panel, which was designed to be part of a 15-year site-specific installation, capable to withstand significant humidity, UV, and IR exposure, had incurred significant structural damage. Panel #5 was valued at \$5,000, within the overall project cost of \$25,000, in 2007.

This panel was on display for 13 years before exhibiting stress damage. It is likely that the location at the north end of the Grand Lobby above the Spatafore Grand Staircase, results in the more environmental exposure than any of the other four panels due to proximity to both overhead skylight and a large wall of windows. The custom-dyed nylon ruptured, resulting in a 32" horizontal tear in 2020, as well as a subsequent 38" vertical tear in 2021. The integrity of the work was lost with the initial rupture and is irreparable.

Additional inspection found wrapped horizontal and vertical edges to be in good condition, with damage likely beginning at a single, small tear on the right edge. All four corners exhibit stress wear and likely would be the source of additional damaged over time. At this time the remaining four panels on display remain in good condition.

As Fabric Panel #5 is no longer fit for public viewing and cannot be repaired, Staff recommends deaccession from the City Art Collection. The artist has been notified of the removal, inspection, and supports any reuse or recycling of the materials by Staff. A portion of the nylon fabric can be retained as a project reference and teaching tool. The wood panel and hardware can be repurposed for use in the Exhibitions Program.
